Home Water Testing

Does your water come from a well, spring, or cistern?

Do you want to learn more about the quality of your water?

How it works:

- 1. Pick up a sample kit from your local Extension office between August 31 and September 4 and get instructions to collect your household water sample.
- 2. Collect a sample from your tap at home and complete a short questionnaire.
- 3. Drop off sample at a designated location and time on September 9.
- 4. About four (4) weeks later, come back to get your confidential test results, an explanation of what the numbers mean, and information on how to handle any problems that are present.

FEE: \$60 per sampling kit
