Your application will be reviewed and the candidates who will best help us meet the needs of environmental/horticultural education in the Prince William area will be selected. Enrollment this year is limited due to Covid constraints.

After your application is approved, your references and a background check with PreSearch, a company contracting with Virginia Tech, will be completed.

If you would like to apply for a scholarship (limited partial and complete scholarships will be awarded) you will receive an email from Christina Hastings, Environment and Natural Resources Administrative Assistant with interview times and a scholarship application. Interviews will be in small groups, if possible, via Zoom.

You will also receive a link to log onto our Canvas, learning platform site to pay applicable fees either by check or credit card. Checks should be made payable to Treasurer, Virginia Tech. There is a returned check fee of \$50 incurred by Bursar of Virginia Tech. Class fees of \$235 cover: a digital Master Gardener manual, Turf Handbook, a magnifying loupe, an invasive plant book a native tree guide and a northern Virginia native plant book, speaker fees, a BEST Lawns assessment and soil test, and a Pest Management Guide.

Classes will begin Tuesday, September 15. Prior to class starting you will need to complete a Virginia Tech Civil Rights video (link will be provided).
